The Judicial branch of the Ho-Chunk is composed of the Supreme Court and the Justice and two Associate Justices. The Trial Court has one Chief Judge and other Associate Judge and other Associate Judge and other Passociate Judges.


The Ho-Chunk Mation Executive branch includes the President of the Ho-Chunk Mation and administrative departments that work for the tribal members created by the Ho-Chunk Legislature. The current administrative departments are; Treasury, Justice, Administration, Housing, Business, Health, Social Services, Education, Labor, and Personnel.

The State of Wisconsin is separated into three districts and everything outside (worldwide) of Wisconsin is known as District 4. The tribe goes through a redistricting every ten years.
